## New Hampshire

### CSBG NETWORK PARTICIPANTS

The New Hampshire State Office administers CSBG funds to 5 Community Action Agencies in 100% of NH counties

In New Hampshire, Community Action Agencies provided services to 101,812 low-income individuals.

43% of families served by the CSBG Network lived below 100% of the Federal Poverty Guidelines

Vulnerable populations served included:

9% of families served in NH were in severe poverty, below 50% of the Federal Poverty Guidelines

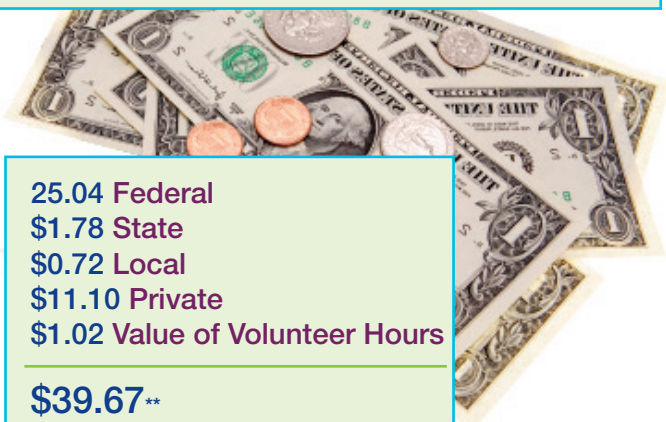


Nationally, of the 6.9 million families served by the CSBG Network, 71.43% were living below 100% of the Federal Poverty Guidelines.

Nationally, over 1,000 Community Action Agencies receiving CSBG funding provided services to 15.9 million individuals with low-incomes.

### CSBG NETWORK RESOURCES

For every \$1 of CSBG, the NH Network leveraged \$39.67 from federal, state, local, and private sources, including the value of volunteer hours\*



\$3,364,697 in CSBG funds were allocated in support of local entities in New Hampshire.

The NH Network's non-CSBG funding totaled \$133,477,533.

## CSBG PERFORMANCE OUTCOMES FOR NEW HAMPSHIRE

Services and strategies provided by the NH Network resulted in **599,974 outcomes for participants and communities with low incomes.**

### Outcomes Include:

**258,581**

#### **Employment**

Participants with low incomes in CSBG Network employment initiatives obtained supports which reduced or eliminated barriers to initial or continuous employment, acquired a job, increased their income, or achieved “living wage” employment and benefits.

**36,480**

#### **Economic Asset Enhancement and Utilization**

Households with low incomes increased their financial assets or financial skills.

**18,996**

#### **Child and Family Development**

Infants, children, youth, parents, and other adults participated in developmental or enrichment programs facilitated by the CSBG Network and achieved program goals.

**38,831**

#### **Independent Living for Vulnerable Populations with Low Incomes**

Vulnerable individuals with low incomes received services from the CSBG Network and secured or maintained an independent living situation as a result.

**41,307**

#### **Family Stability**

Participants with low incomes obtained supports which reduced or eliminated barriers to family stability through assistance from the CSBG Network.

**36,156**

#### **Emergency Assistance**

Individuals and families with low incomes received emergency assistance from the CSBG Network.

**153,898**

#### **Community Opportunities and Resources**

Community opportunities or resources were improved or expanded for people with low incomes as a result of CSBG Network projects or initiatives, or partnerships with other public and private agencies.

**15,725**

#### **Community Empowerment**

Community members and people with low incomes mobilized to engage in activities that support and promote their own well-being and that of their community as a result of CSBG Network initiatives through maximum feasible participation.
